- South Jersey Catholic: Feature article!
- New 20 year logo. Bishop McHugh is celebrating its 20th year with a newly unveiled logo.
- Re-registration for 2020-21: Initial update. As of 12/4/19 33 students re-registered. Reminders going out after the new year.

Old Business

- 50/50 Update- As of 12/4/19 total gross is \$5,675. Sold approximately \$1,000 at St. Joseph weekend of 12/14, 12/15.
- Yankee Candle- In progress. Open until 1/8/20. Total sales through 12/4/19 are \$1,258.20. Down approximately 50% from last year. Discussed having sale every other year to mix it up and keep it fresh.
- SCRIP Update- a Remind will be sent out regarding invitation to sign up.
- Color Run Recap- Success! Raised approximately \$3,717 vs \$1,783 in 2018. Online access made significant difference. Over \$2,000 raised via online donations. Having students send out donation requests via email were successful. Moving forward we hope to have incentives earlier for students and families to solicit, i.e. NUT cards.
- Bag Bingo- Up and running! #1 priority is ticket sales. Currently posting flyers and advertising in church bulletins. Still need donation baskets.
- Movie Night tickets- As of 12/4/19 90 tickets had been sold totaling \$720 in profit for the school. Great work, Michelle Mitchell!

New Business

- Committees are in place for Casino Night (Deb Pasceri, Ali Edwards & Mags Gleeson) and Golf (Lindsey Vince, Jamie Mulholland, Anita McMahon & Christy Carr.)

- Resignations of Financial Officer and Fundraising Coordinator have been accepted. Where do we go from here?? PATH board voiced the need to maintain a fundraising coordinator position. PATH is looking to work with Board of Pastors and administration to maintain current successful fundraising trajectory via online fundraising platform, Bloomerang. This is a high priority item. Administration indicates Bloomerang can not go “live” until new Financial Officer is hired. Administration also indicates the Fundraising Coordinator position will not be filled. Nancy Fenstermaker is currently managing the Bloomerang database.
