## DECLARATION OF DISTRICT RESIDENCY BASED ON PARENT EMPLOYMENT

We are hereby informed and believe that this notarized Declaration of District Residency Based on Parent Employment is a public record within the meaning of California Government Code Section 6201 which provides that:

*“Every person not an officer referred to in Section 6200 [falsification of public records], who is guilty of any of the acts specified in that section, is punishable by imprisonment in the state prison, or in a county jail not exceeding one year, or by a fine not exceeding one thousand dollars (\$1,000), or by both such fine and imprisonment.”*

We are further informed and believe that Penal Code Section 134 provides in pertinent part that:

*“Every person guilty of preparing any false . . . instrument in writing . . . with intent to produce it . . . for any fraudulent or deceitful purpose, as genuine or true, upon any . . . inquiry whatever authorized by law, is guilty of a felony.”*

(Education Code 48204 / AR 5111.12)
